Sub: Transfer of "Schemes of Polytechnics' from MSDE to DGT.

The undersigned is directed to say that a meeting under the Chairmanship of Secretary, MSDE was held on 01.06.2018 in Conference Room, Shivaji Stadium Annexe Building to review of the 'Schemes of Polytechnics'.

- 2. The following decisions were taken in the meeting:
 - (a) The 'Schemes of Polytechnics' which was transferred from MHRD vide letter No. 5-5/2016-TS-IV/945/17 dated 05th July, 2017 without fund and manpower, now stands transferred to Directorate General of Training (DGT) with immediate effect.
 - (b) All files relating to the following four sub-schemes of Polytechnics may be transferred along with all documents, records and UCs received from MHRD to DGT.
 - (i) Setting up of new Polytechnics in Un-served & Underserved Districts;
 - (ii) Central Assistance for construction of Women's Hostels in selected Polytechnics;
 - (iii) Central Assistance for up-gradation of selected Polytechnics;
 - (iv) Scheme of Community Development through Polytechnics (CDTP)
 - (c) DGT shall create a separate cell for 'Schemes of Polytechnics' to be headed by a Director. The Director shall be supported by a Joint Director/Deputy Director and other supporting staff for smooth implementation of the scheme.
 - (d) DGT shall ensure scheme-wise updating all records including allocated fund, expenditure and updating of UCs in coordination with different States/ UTs.
 - (e) DGT shall also pursue and coordinate for early sanction of EFC of all above schemes as presently under consideration with Ministry of Finance. CDTP scheme to be continued as per existing design depending upon the fund and liability and shall be reviewed after sanction with revised scope and design of CDTP scheme as submitted in the EFC.DGT should also coordinate with Finance Division for allotment of funds in respective heads as per the changes of shifting of schemes from MSDE to DGT.

- (f) DGT shall give future action plan including considering various points as recommended in the evaluation report against above schemes.
- 3. List of files pertaining to above schemes opened in MSDE have already been sent to DGT. Here, it may also be noted that some files/records might be with MHRD. So DGT may ensure with MHRD for the same. Further, the ongoing cases of Polytechnics schemes, which needs prompt action have also been handed over to Sh. Amrit Pal Singh, DD, DGT.
- 5. Since a large number of bundles of files pertaining to Polytechnics schemes received from MHRD are with IC&T Wing, DGT may please take necessary action to collect all these files.
- 6. This issues with the approval of Secretary, MSDE.
