ORDER

Consequent upon the recommendations of Selection Committee, Shri Aman Singh has been engaged as Young Professional (YP) in the Ministry of Skill Development & Entrepreneurship (MSDE) purely on contract basis w.e.f. 07.10.2020 and posted to Economic & Policy Wing of this Ministry. The terms and conditions of appointment are as under:-

- a) **Remuneration:** A consolidated salary of Rs. 70,000/- per month (all inclusive).
- b) **Increments:** Young Professional will not be eligible for any further increment during your period of engagement.
- c) Allowances: The Young Professional shall not be entitled to any allowances such as DA, HRA, CGHS, Medical reimbursement or any other relief etc.
- d) **Period of engagement:** The engagement will be for a period of 2 years from the date of joining. The engagement will, however, be liable to be terminated at any time without assigning any reasons therefore, at the sole discretion of the competent authority. The Young Professional can resign from the post by giving one month prior notice.
- e) **Duties & Responsibilities:** As may be assigned by the Competent Authorities of MSDE.
- f) Leave: Young Professional will be eligible for 08 (eight) days of leave during a calendar year on pro-rata basis and leave over and above 08 days will be deducted from the salary. Also, un-availed leave during the period of engagement will stand lapse.
- g) **TA/DA:** TA/DA on official journey shall be paid as per relevant Rules. However no TA/DA shall be paid for joining the Ministry.
