VACANCY CIRCULAR

Sub: Appointment of Consulting Advisor in National Council for Vocational Education & Training (NCVET) - reg.

The National Council for Vocational Education and Training (NCVET) notified by Government of India on 5th December, 2018, has been established as an overarching regulator in the skilling ecosystem mandated to regulate both long and short-term vocational training in the country.

2. Applications are invited, in the given proforma, from the citizens of India for the posts (2 nos.) of Consulting Advisor, on contract basis, in the National Council for Vocational Education and Training (NCVET).

3. Eligibility:

- (a) Applicant must be a Government servant who has retired/will be retiring latest by December 31st, 2020 at least at Additional Secretary level to Government of India or equivalent.
- (b) The applicant should not be more than 62 years of age as on the last date of receipt of application that is 4th December 2020.
- (c) The person should have at least two years experience in the skilling domain, and preference would be given to persons having experience in the skill regulatory framework.
- 4. **Tenure**: The period of contract shall be for one year or further orders, whichever is earlier. The contract can be extended, if NCVET feels the necessity for it, for maximum two more times, for period of one year at a time, or less. Thus, the maximum period the Consulting Advisor can function shall be for three years.
- 5. **Pay and Emoluments**: The pay and allowance of the Consulting Advisor will be regulated as per extant DoPT rules for retired persons.
