**Note 1:** The Departmental Officers in the Feeder Category who are in the direct line of promotion will not be eligible for consideration for appointment by deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion. (Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government should ordinarily not to exceed *three* years. The maximum age limit for appointment by deputation shall not exceeding 56 years as on the closing date of receipt of application).

**Note 2:** For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1.1.2016 (the date from which the revised pay structure based on the 7<sup>th</sup> Central Pay Commission recommendations has been extended) shall be deemed to be service rendered in the correspondence grade pay or pay scale extended based on the recommendations of the Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a

common grade pay or pay, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.


2. The deputation will be governed contained in the DOP&T O.M. No. 6/8/2009-Estt(Pay-II) dated 17.6.2010 as amended from time to time.

3. It is requested that the particulars of the eligible persons, who fulfil the required qualification and can be considered for appointment to the above posts and whose services could be spared immediately may be forwarded to this office in the proforma enclosed along with their vigilance clearance, integrity certificate, No penalty certificate for the last ten years and up-to-date ACRs/APARs for the last five years, so as to reach this office latest by **08.10.2021**.
