Important Activities of Ministry of Skill Development & Entrepreneurship for the month of November 2024

- Hon'ble Minister of State (I/C), SDE, Shri Jayant Choudhary personally handed over job offer to more than 2400 youth in a 'Kaushal Mahotsav' event organized at Bharatpur on 19th November, 2024.
- On the occasion of Constitution Day to commemorate the adoption of the Constitution of India, the Preamble to the Constitution was read on 26th November, 2024 at Kaushal Bhawan Building, New Moti Bagh, New Delhi. The Janjatiya Gaurav Divas was also celebrated across the NSTIs.
- Hon'ble Minister of State (I/C), SDE had a meeting with the Hon'ble Minister of Women and Child Development regarding skilling initiative for Adolescent Girls and convergence between the two Ministries on 26th November, 2024.
- A Joint Working Group (JWG) for the renewed MoU on Cooperation in the fields of Skill Development and Vocational Education and Training (VET) between India and Germany has been constituted by both sides.
- On 5thNovember 2024, a meeting was held with Dr. Beh Swan Gin, Permanent Secretary for Ministry of Trade and Industry (MTI), Singapore to discuss their proposal for "India Singapore Skills Cooperation Joint Flagship Programme for Skills Training".
- Hon'ble Minister of State (I/C), SDE hosted an industry delegation from Austria, headed by Vice President, Chamber of Commerce to discuss potential partnership in skill development and entrepreneurship between India and Austria.
- MSDE participated in the 25th India-Russia Intergovernmental Commission for Trade, Economic and Scientific and Cultural Cooperation (IRIGC-TEC) co-chaired by External Affairs Minister and 1st Deputy Prime Minister of Russia on 12th November, 2024 to *inter alia* discuss the way forward for skill cooperation agenda with Russia. It also hosted a delegation from St. Petersburg, Russia headed by Mr. Sergei Leonovich Markov, First Deputy Chairman of the St. Petersburg Committee for External Relations on 13th November, 2024 to further explore the skill cooperation between India and Russia.
- MSDE undertakes skilling, reskilling, and upskilling initiatives under two of MNRE's schemes, namely the National Green Hydrogen Mission (NGHM) and the PM Surya Ghar Muft Bijli Yojana (PMSGMBY) (for Rooftop Solar PV Installation and Maintenance). Under PMSGMBY, 36,646 trainees, have been providing 5-day institutional training and 26,278 trainees have completed their 2 days On-the job training so far.
- Under the Pradhan Mantri Janjatiya Unnat Gram Abhiyan of the Ministry of Tribal Affairs (MoTA), launched in September 2024, MSDE will be implementing the skilling and entrepreneurship development component under the scheme from Financial Year 2024-25.
- Establishment of 30 new skilling centres in 30 identified tribal districts in the country under JSS

- Building the capacity of 1,000 Van Dhan Vikas Kendras (VDVKs) aligning with the capacity-building efforts of PM JANMAN Scheme
- MSDE through its autonomous institutes, namely, National Institute for Entrepreneurship and Small Business Development (NIESBUD) and Indian Institute of Entrepreneurship (IIE), Guwahati is implementing the skilling and entrepreneurship components of PM-JANMAN. The project is being implemented with the support of the Tribal Cooperative Marketing Development Federation of India (TRIFED). Under this a total of 500 VDVK is to be set up by TRIFED. A total of 42,000 PVTG beneficiaries are to be trained under PM-JANMAN.

- Approximately 160 ITIs have been mapped on the NCVT MIS portal. Around 13.5 lakh (CTC ZONE) trainees date have been migrated from state portal to SIDH.

- NIMI has been designated as a training partner (TP ID: 261249) under the PM Vishwakarma Scheme, and the NSTIs have been enrolled as training centers under NIMI. As on date, 21 NSTIs have commenced training, and 1275 candidates have completed basic training. NIMI has been disbursing the payments for trainers, raw materials, AEBAS Machine and branding. NIMI played a key role in disbursing the funds allocated for the 1st anniversary celebrations of the PM Vishwakarma Scheme, with 13 of its enrolled training centers selected for the event. So far ₹23,18,240 has been disbursed to cover the expenditure incurred by the NSTIs.
